This panel will explore the investigative means used to trace the location or identity of perpetrators in cybercrime and fraud cases. They will show us live how perpetrators can be located, what a proper chain of custody looks like, and how to challenge the chain of custody of digital evidence presented by the prosecution.

Interpol and Transnational Repression

The session will explore key themes from the ECBA's draft position paper on INTERPOL reform, including disclosure, pre-emptive red notices, asylum, and the use of INTERPOL tools in transnational repression.
