Some Other "Environmental Crimes"

- 1. Section 61(5) of the Control of Pollution Act 1974: Construction Noise;
- 2. Section 80(4) of the Environmental Protection Act 1990: Failing to Comply with an Abatement Notice. Section 82 of the same Act provides criminal sanctions against those who commit a statutory nuisance;
- 3. Section 85 of the Water Resources Act 1991: Polluting Controlled Waters;
- 4. Various "arrestable offences" under the Countryside and Rights of Way Act 2000;
- 5. Various criminal offences under the Pollution Prevention and Control Act 1999 (which seeks to put into effect Dir. 96/61/EC O.J. No. L257/26, namely the Integrated Pollution Prevention and Control Directive). Regulations governing the operation of installations regarding emissions;
- 6. The commission of a Public Nuisance is a criminal offence. A nuisance is a Public Nuisance when it "materially affects the reasonable comfort and convenience of the life of a class of Her Majesty's Subjects" (per Romer LJ in *Attorney General -v- PYA Quarries Limited and GLC* 1957 2 QB 169 at 184);
- 7. Section 28P of the Wildlife and Countryside Act 1981 creates offences in relation to Sites of Special Scientific Interest.
